Press Trip Release of Liability

01 By accepting the offer by the Jordan Tourism Board North America, I agree to the terms set out in this Release of Liability. Arrival in Jordan will be handled by the Jordan Tourism Board North America as acceptance of these terms.

02 **I UNDERSTAND THAT REFERENCE IN THIS AGREEMENT:**

a. To the Jordan Tourism Board North America includes organizations affiliated with the Jordan Tourism Board North America, including without limitation their international representative offices and also include the officers, directors, managers, employees, agents or contractors of the Jordan Tourism Board North America of those organizations; and

b. to me include my heirs, distributees, guardians, legal representatives or assigns.

03 **I AGREE AND ACKNOWLEDGE THAT:**

a. The Jordan Tourism Board North America has assisted to coordinate certain travel arrangements and related services (the Travel Services) on my behalf;

b. The Jordan Tourism Board North America will not arrange any insurances for me or on my behalf in connection with the Travel Services;

c. that in connection with the Travel Services, it is prudent for me to insure against:

- death or injury how so ever caused;
- loss of or damage to property; and
- liability, however arising, to third parties for death or injury or loss of or damage to property

d. The Jordan Tourism Board North America is not itself a tour operator, travel agent, carrier or hotelier, nor do we own aircraft, hotels or coaches. We exercise every care in the selection of reputable tour operators, travel agents, airlines, coach operators, hotels, cruise line operators, and other suppliers of health services, etc or the various travel services which are used in these tours. It is important to note, therefore, that all bookings are subject to the terms and conditions and limitations of liability imposed by tour operators, travel agents, airlines, coach operators, hoteliers and other service providers, including but not limited to shipping, rail, car hire and restaurant operators, whose services are utilised, some of which limit or exclude liability in respect of death, personal injury, delay and lost or damage to baggage. We strongly recommend that you take out travel insurance against these risks.

e. The Jordan Tourism Board North America always does its best to ensure your tour arrangements are satisfactory. However, we cannot accept any liability of whatever nature for the acts, omissions or defaults, whether negligent or otherwise, of those tour operators, travel agents, airlines, coach operators, shipping companies, hoteliers or other persons providing services in connection with your tour pursuant to a contract between themselves and yourself (which may be evidenced in writing by the issue of a ticket, voucher, coupon confirmation of the like) and over whom we have no direct or exclusive control.

f. We do not accept any liability in contract or in tort for any injury, damage, loss, delay, additional expenses or inconvenience caused directly or indirectly by force majeure or other events which are beyond our control, or which are not preventable by reasonable diligence on our part including but not limited to war, civil disturbance, fire, floods, unusually severe weather, acts of God, acts of Government or of any authorities, accidents to or failure of machinery or equipment or industrial action (whether or not involving our employees and even though such action may be settled by acceding to the demands of a labor group).

I agree to release the Jordan Tourism Board North America from any claim by me in respect of death or injury however caused or loss of or damage to property arising out of or in connection with the Travel Services including claims arising from the negligent acts or omission of the Jordan Tourism Board North America.

- 05 I agree to indemnify the Jordan Tourism Board North America against all losses, expenses, damages and costs incurred by or awarded against Jordan Tourism Board North America as a result of death or injury or loss of or damage to property caused by, or contributed to, by me in connection with the Travel Services.
- 06 If any part of this agreement is invalid or unenforceable in a particular jurisdiction, that part shall apply only to the extent lawfully possible or shall be excluded from the agreement in that jurisdiction but only to the extent of the invalidity or unenforceability, and it does not affect the validity or enforceability of that provision in another jurisdiction or the remaining provisions in any jurisdiction.
- 07 As a journalist/content creator/influencer who has been sponsored by the Jordan Tourism Board North America, I hereby agree that I will provide the Jordan Tourism Board North America with a copy (digital or print) of any published article/blog/post relating to or arising from my participation in this program, in a timely manner. I undertake to ensure that the Jordan Tourism Board North America has the right to distribute any such article/blog/post to participants in the tourism industry that have been involved in the visit or as mentioned in any such article/blog/post. I agree to indemnify the Jordan Tourism Board North America against any action, proceeding, cause or claim against the Jordan Tourism Board North America in relation to such distribution.
